Our mission is to support and promote the religious and gospel mission of the Columbia Union by providing a source of financing for eligible Seventh-day Adventist entities within the Columbia Union. We raise money for our Revolving Fund by selling Notes to Qualified Offerees exclusively. We pay interest on the Notes we sell.</p> <p>We offer the Notes Exclusively to “Qualified Offerees,” meaning: (i) persons who reside in Delaware, the District of Columbia, Maryland, New Jersey, Ohio, Pennsylvania, Virginia, or West Virginia and who hold membership in churches within the Seventh-day Adventist religious denomination; and (ii) entities affiliated with the denomination located within these jurisdictions for themselves or as trustees or administrators of trusts or other fiduciary programs. Trusts or other fiduciary programs administered by denomination-affiliated entities may purchase the Notes in the name of the applicable denomination-affiliated entity for the benefit of the specified beneficiaries.</p>
